

MEMORANDUM OF UNDERSTANDING
BETWEEN
THE DEPARTMENT OF PUBLIC SAFETY AND EMERGENCY PREPAREDNESS
OF CANADA
AND
CRIME PREVENTION FUND – IGA, BULGARIA

CONCERNING THE LICENSE OF SEX-OFFENDER RISK ASSESSMENT TOOLS

The Department of Public Safety and Emergency Preparedness (Public Safety Canada) and Crime Prevention Fund – IGA, Bulgaria (IGA), hereinafter referred to as the "Participants",

Wishing to set forth the scope of licensing arrangement carried out under the signed Licence Arrangement for Sex Offender Risk Assessment Tools, attached as Schedule "A" to this MOU (the "Licence"),

Understanding that the Sex Offender Risk Assessment Tools (Assessment Tools) are a data set comprised of the following Assessment Tools, STATIC 99, Coding Rules - Revised 2003, STABLE 2007 and ACUTE 2007, further described in Schedule "A" attached hereto,

Understanding that Public Safety Canada has developed the Assessment Tools and that IGA has requested Public Safety Canada to use the Assessment Tools and to Assessment Tools support;

Have come to the following understanding:

1. OBJECTIVE AND SCOPE

- (a) The objective of this MOU is to establish the scope of licensing arrangement carried out under the Licence.
- b) The scope of this MOU includes the provision of a license granted by Public Safety Canada for the use of the Assessment Tools by the IGA, along with an information package on the Assessment Tools, user-guidance and other relevant information as deemed appropriate to share under the Licence of this MOU to assist IGA in the use of the Assessment Tools.

2. ROLES OF EACH PARTICIPANT

- (a) Public Safety Canada will:
 - (i) Provide the Assessment Tools, upon the execution of the License, to IGA for the purpose of allowing prison officers and experts, employed in Bulgaria by IGA and by the General Directorate Execution of Penalties at the Ministry of Justice to evaluate the recidivism risk of sexual offenders;
 - (ii) Provide to IGA a point of contact for periodic technical questions, though not technical support, should they surface during the use of the Assessment Tools; and
 - (iii) Provide the IGA information and user-related information materials, as deemed

appropriate by Public Safety Canada, to assist IGA in the use of the Assessment Tools.

(b) IGA will:

- (i) Only use the Assessment Tools in accordance with the terms of the License;
- (ii) Ensure the translation of all written documents into Bulgarian and cover any and all expenses and costs incurred in the translation;
- (iii) Monitor the application of the Assessment Tools and ensure a consistent approach in the use of the Assessment Tools;
- (iv) Assist Public Safety Canada with its pilot projects and evaluate the utility and effectiveness of Assessment Tools;
- (v) Identify opportunities and challenges for broader cross-border application of the Assessment Tools if deemed appropriate in future discussions; and
- (vi) Inform Public Safety Canada of any deficiencies in the Assessment Tools or other operational difficulties, and any actions taken to address or resolve such errors, issues, and other difficulties.

(c) Both Participants will discuss the possible cross-border application of the Assessment Tools as appropriate prior to, during the course of, or following execution of the License.

3. ASSESSMENT TOOLS SUPPORT

(a) Public Safety Canada will not include Assessment Tools training as part of this MOU. Public Safety Canada may provide supporting materials at the time the Assessment Tools is provided to IGA.

4. POINTS OF CONTACT

(a) The Participants designate the following points of contact to implement this MOU and coordinate the respective Participants' activities:

- (b) The Participants will send all correspondence to their respective points of contact.
- (c) The Participant will notify the other Participant in writing of any change of address or fax number.
- (d) Participants will ensure that their points of contact hold an annual teleconference, or more frequently if needed, to:
 - (i) Measure progress on the joint outcomes and results; and
 - (ii) Review and, if needed, update this MOU

5. FINANCIAL ARRANGEMENTS

- (a) Participant will assume the costs it incurs in the application or in relation to this MOU.
- (b) Public Safety Canada will provide the Assessment Tools and the support described in subparagraph 3 (a) of this MOU to IGA free of charge
- (c) IGA will use the Assessment Tools in conformity with the terms and conditions of the License.

6. ASSISTANCE AND USE OF ASSESSMENT TOOLS

- (a) Within thirty (30) calendar days of the date of entry into effect of this MOU, Public Safety Canada will provide IGA with technical assistance and related information as it deems appropriate in order to effectively use the Assessment Tools.
- (b) IGA will maintain an inventory of all equipment and material received from Public Safety Canada under this MOU and will report to Public Safety Canada of any equipment or material that is consumed, damaged, or destroyed;
- (c) IGA will only use the Assessment Tools for Governmental purposes, subject to the intellectual property rights set out in the License

7. Damages

- (a) The Participants do not intend for Public Safety Canada to be responsible for any damages to individuals or property, or any other claims of loss or damage resulting from the use of the Assessment Tools.

8. EXPORT CONTROLS

- (a) The Participants will each conform to their own respective national export control laws.
- (b) IGA will not re-export the Assessment Tools to another jurisdiction.

9. INFORMATION SHARING

- (a) The Participants will exchange information under this MOU in accordance with their applicable laws, regulations and policies.

- (b) Public Safety Canada will mark the information provided under this MOU that is not public as "Her Majesty the Queen in Right of Canada for Official Use Only. IGA will mark the information provided that is not public as "Bulgaria for Official Use Only" to the extent that it is practical to mark the material. The Participant that supplies information orally will confirm it with a written notice to the receiving Participant within twenty-four (24) hours.
- (c) Participants will classify the information received "for Official Use Only from the other Participant in accordance with any laws, regulations and policies to which each Participant is subject and the information will be protected in accordance with those laws, regulations and policies. In order to facilitate their collaboration under this MOU, the Participants may negotiate an additional arrangement that will outline specific security responsibilities, safeguards to be applied, and terms and conditions for the direct sharing of classified information.
- (d) Participants will only disclose information in conformity with any laws or regulations to which each Participant is subject or if a court order requires it. The other Participant may oppose such disclosure in conformity with the applicable laws and regulations.
- (e) Document, regardless of medium or form, exchanged between the Participants will be treated and disposed of in accordance with the laws and policies applicable to each Participant.

10. DIFFERENCES IN INTERPRETATION AND APPLICATION

- (a) The Participants will resolve any difference regarding the interpretation or implementation of this MOU by consultation and will not refer such differences to a national or international tribunal or any other third party for settlement.

11. APPLICABLE LEGISLATION

- (a) The MOU is not legally binding and places no international or domestic legal obligation on them. The Participants will ensure that any activities done under this MOU is done in conformity with the foreign policy, international obligations and the domestic law of the respective state of each Participant.

12. DURATION, WITHDRAWAL AND TERMINATION

- (a) This MOU will take effect on the date of its signature by the Participants.
- (b) Either Participant may withdraw from this MOU upon presentation of sixty (60) days written notice to the other Participant.
- (c) The Participants may modify this MOU upon their mutual written consent.
- (d) The Participants may terminate this MOU at any time, with the mutual written consent of the Participants.



SCHEDULE "A"

LICENSE ARRANGEMENT FOR SEX OFFENDER RISK ASSESSMENT TOOLS

This License made of the 29 day of July, 2014

BETWEEN:

**THE DEPARTMENT OF PUBLIC SAFETY AND EMERGENCY PREPAREDNESS
(Canada)**

AND:

CRIME PREVENTION FUND – IGA, BULGARIA (Licensee)

WITNESSES THAT:

- I. **WHEREAS** Canada is the owner or licensee of all intellectual property rights in the following assessment tools, commonly known as:
- i. STATIC 99 and the Revised 2003 Coding Rules;
 - ii. STABLE 2007; and
 - iii. ACUTE 2007.

as described in License "A" attached hereto (the "Assessment Tools")

- II. **AND WHEREAS** the Licensee is interested in acquiring certain rights to the Assessment Tools, in accordance with the terms and conditions contained herein; and
- III. **AND WHEREAS** Canada is willing to grant to the Licensee certain rights to the Assessment Tools, in accordance with the terms and conditions contained herein;

NOW THEREFORE, in consideration of the understandings contained in this License, the Participants have reached the following understandings:

1.0 DEFINITIONS

1.1 "Assessment Tools" means the Data commonly known as STATIC 99, Coding Rules - Revised 2003, STABLE 2007 and ACUTE 2007, further described in License Annex "A" attached hereto.

1.2. "Canada's Data" means that Data contained in the Assessment Tools, the Intellectual Property Rights of which vest in Canada.

1.3. "Certified Users" means an individual who has successfully completed training on actuarial risk assessments for sex offenders provided by Accredited Trainers, to whom the Licensee licenses, on an end-use basis, all or part of the Assessment Tools, in accordance with the terms and conditions of this License, including those set out in License Annex "B" attached hereto.

"Data" means any expressed original data fixed in a form giving rise to Intellectual Property Rights, such as described in License Annex "A" attached hereto.

"Intellectual Property Rights" means any and all intellectual property rights recognized by the law, including but not limited to, intellectual property rights protected through legislation.

"Licence" means this Licence Arrangement for Sex Offender Risk Assessment Tools, its recitals and the Licence Annexes attached hereto, as the same may be amended from time to time in accordance with the provisions hereof.

"Participant" and "Participants" means any one or both of the signatories to this Licence, as the context may dictate, and their respective employees.

2.0. INTELLECTUAL PROPERTY RIGHTS

2.1. Subject to paragraph 2.2 of this Licence, and without affecting Canada's Intellectual Property Rights in and to Canada's Data and any third party Intellectual Property Rights in Data contained in the Assessment Tools, all subsequent Intellectual Property Rights developed by the Licensee for the purpose of exercising its rights hereunder, other than the translation of the Assessment Tools, will vest in the Licensee or in such person as the Licensee shall decide.

2.2 a) All Intellectual Property Rights in and to Canada's Data will remain the property of Canada.

b) All Intellectual Property Rights in and to any translation of the Assessment Tools, which may be performed by the Licensee in the exercise of its rights hereunder, will vest in Canada;

c) All Intellectual Property Rights in and to the Data contained in the Assessment Tools which is not Canada's Data will remain the property of the respective content owners and may be protected by copyright, other intellectual property laws or international treaties.

3.0 LICENCE GRANT

3.1. Subject to this Licence, Canada hereby grants to the Licensee a royalty-free, non-exclusive, world-wide, non-assignable licence to use the Assessment Tools, in whole or in part, for the Licensee's own internal use for the whole of the period of time described in paragraph 6 and paragraph 7 below (Term), provided:

a) the Licensee will not, nor allow or direct itself, nor any Licensee employee or related third parties:

(i) to possess or use the Assessment Tools, unless they are a Certified User who has completed the necessary training from an Accredited Trainer.

(ii) to modify, or in any way attempt to alter the Assessment Tools or any part thereof.

(iii) to merge or link the Assessment Tools with any product or database in such a fashion that gives the appearance that the Licensee may have received, or had access to,

information held by Canada about any identifiable individual, family, household, organization or business.

3.2. The Licensee will take all necessary steps to ensure that the Assessment Tools cannot be used after the expiration of this License under paragraph 6 or paragraph 7 of this License.

4.0 OBLIGATIONS OF THE LICENSEE

4.1. The Licensee will not use the Assessment Tools in any way which, in the opinion of Canada, may bring disrepute to or prejudice the reputation of Canada.

5.0 REPRESENTATIONS, WARRANTIES, INDEMNITIES

5.1. Canada makes no representation and gives no warranty of any kind with respect to the accuracy, usefulness, novelty, validity, scope, completeness or currency of the Assessment Tools and expressly disclaims any implied warranty of merchantability or fitness for a particular purpose of the Assessment Tools.

6.0 TERM

6.1. This License is effective as of the date of the last signature of the Participants.

6.2. Provided the Licensee is not in breach of any of the terms and conditions of this License, this License will remain in effect until (date), and be automatically renewed annually for successive one (1) year terms, subject to paragraph 7 of this License, unless either Participant gives written notice to the other Participant of the non-renewal of this License at least thirty (30) days prior to the end of the then-current term.

7.0 TERMINATION

7.1 Notwithstanding paragraph 6 of this License, this License may be terminated prior to its expiration:

(a) automatically, upon Canada giving written notice to the Licensee of termination of the License by reason of default, if the Licensee commits or permits a breach of any of the terms and conditions of this License;

(b) upon written notice of termination given by either Participant at any time, and such termination will take effect five (5) days after the date of notice;

(c) or upon mutual written consent of the Participants.

8.0. NOTICES

8.1. Any report or notice required or permitted to be given by the Participants under this License will be in writing and given by delivering it in person, or sending it by mail, courier or facsimile addressed as follows:


